

# FRANCISCO GIL DÍAZ President, Telefónica México Former Secretary of Finance and Public Credit, Mexico Former Deputy Governor, Banco de México

Francisco or "Paco" as Francisco's are known throughout the Spanish-speaking world, was born in 1943, is married to Margarita White, a successful model, beauty care entrepreneur and radio commentator. Together they have spawned a diversified portfolio of 4 children, the eldest Francisco with a Masters in Social Science from the University of Chicago and a PhD in Anthropology from UCLA; followed by Gonzalo an investment banker, lawyer from ITAM with an MBA from Stanford; then Cristina a chemist from Universidad de las Américas in Puebla and a Masters from Instituto Tecnológico de Estudios Superiores de Monterrey in Environmental Chemistry; and finally Paulina, a corporate lawyer also from ITAM and a Master's in Law and Diplomacy from Fletcher. Gonzalo in turn is contributing with Brenda, our daughter in law, to make sure that Mexico's vibrant demographic expansion continues unabated with our 4 beautiful grandchildren.

Paco's BA is from ITAM, the prestigious Mexico City private university, and has a Master's and PhD in Economics from the University of Chicago.

His professional career has combined academia with government service and two stints in the private sector, the first as President and CEO of Avantel, at the time the 2<sup>nd</sup> largest telecommunications firm in Mexico and since February 2007 as President of Telefónica México, the 2<sup>nd</sup> largest mobile phone operator in Mexico. As an academic, Paco has taught mostly at ITAM. He also has taught at Universidad Iberoamericana, El Colegio de México and Universidad Nacional Autónoma de México. He has published extensively on subjects that range from taxation to monetary policy, as well as works related to government budget categories and crises management.

# Career Path:

In his capacities as a public official, as an academic and as a private citizen, Gil-Díaz has played a role in advancing Mexico's market oriented economic policies.

His public service experience has had him alternate between the central bank and Mexico's Treasury Department. At the Treasury he first held the position of General Director of Fiscal Planning, followed by General Director of Revenue Policy, then Undersecretary for Revenue and finally as Treasury Secretary under President Vicente Fox. At the Central Bank he started as economic analyst, eventually headed the Research Department, with a final responsibility at the bank as member of its Board of Governors.

Paco has imparted conferences on different topics at universities such as Chicago; Harvard; British Columbia; Princeton; UCLA; Santa Barbara; Santa Cruz; San Diego; Stanford; Columbia; New York University; Colorado at Boulder; CATO; Instituto de Empresa in Madrid, Spain; ITAM; CIDAC; UNAM; IPADE; Universidad Iberoamericana, etc.

His sports range from windsurf sailing, to alpine skiing, to mountain biking, all of which he performs with little proficiency but unmitigated enthusiasm.
